### End-User Agreement

*Provided that you have paid the license fee (included in your original purchase price), your rights package is as follows:*

1. "SceneScape" refers to the three-CD set of expressive music textures, drones and ambient underscores composed and recorded by Mark Mercury.
2. SceneScape is licensed by SceneScape Music Library/VIP Productions Inc. to *one user* (defined as "one person" or "one production company at one business location").
3. This license is for synchronization rights only (the right to synchronize the music contained in the SceneScape CDs in timed-relation with audio and/or audiovisual productions, e.g. film, radio, television, multimedia, live presentation, websites).
4. You may create copies of your audio and/or audiovisual productions which contain synchronized audio material from SceneScape. However, you may not copy, duplicate, provide access to, sell, lease, loan, or give away unsynchronized SceneScape content by any means or any delivery method now known or which shall come into existence.
5. You may not transfer SceneScape music to any format which allows for network or remote access by third parties unless a separate Multi-User Agreement is obtained.
6. SceneScape audio material may not be changed or altered in any way (except for ordinary cutting and pasting in order to meet timing requirements) and words/lyrics cannot be added without the express written consent of the copyright owner.
7. With respect to the music contained in SceneScape, this license does not include performing rights. All the compositions in SceneScape were composed by Mark Mercury (ASCAP) and are published by Blue Chromium Music (ASCAP).
8. The master recordings and copyrights contained in SceneScape are owned by Mark Mercury/Blue Chromium Music and are protected by copyright laws and international treaty provisions. All rights are reserved except as expressly granted herein.
9. This license is not transferable without express written permission from SceneScape Music Library/VIP Productions Inc. or its authorized distributor.
10. An additional license must be obtained from SceneScape Music Library/VIP Productions Inc. when more than 10,000 (ten thousand) copies of any one production

are produced for sale (including but not limited to DVDs, Videos, CD-ROMs, merchandise, promotional items).

If you synchronize any SceneScape music in any production that is to be used for broadcast or public performance or any other medium or means of performance that is licensed by ASCAP, you agree to promptly notify SceneScape Music Library so that we may prepare or help you prepare the appropriate music cue sheets and submit them to ASCAP.

12. SceneScape music may be used and/or embedded in websites or included in programs which are broadcast/webcast on the internet provided that the music is streamed and cannot be downloaded or duplicated.

SceneScape Music Library/VIP Productions Inc. warrants that the Licensee's use of SceneScape audio material in accordance with the terms of this License does not infringe on the proprietary rights of any third party. SceneScape Music Library/VIP Productions Inc. does not accept responsibility for any loss of business or business profits resulting directly or indirectly from the performance of any of the audio material contained in SceneScape. SceneScape Music Library/VIP Productions Inc.'s liability is limited and restricted solely to the replacement at no charge of any defective SceneScape CD.
